RRTA Committee Reports for the 2021 AGM

Social Committee Report

It has been a rocky few years for social functions in the RRTA. We tried very hard to hold a Christmas Luncheon in 2021, only to end up cancelling it when informed that with restrictions in place at that time, we would NOT be allowed to move around the room and socialize. We would have to enter with masks, and immediately take our places at the tables. Masks to be worn at all times when moving around the room such as for visiting the buffet table or going to the washrooms. We felt this would not give our members the experience they would want, so, cancelled the event.

We are pleased to report that with the lifting of restrictions, we can now go ahead with a fall luncheon in the style to which we have become accustomed.

You will notice a cost increase. As you are aware, the cost of food has increased and that means a larger charge by Mayfair for the meal. In addition, in the past, Mayfair Lakes waived the room rental fee for us and only charged per meal. They have now decided to charge a reduced room rental fee as well. The RRTA will pay this fee and will continue to subsidize the meal cost, but the cost to members will still be \$30 for this luncheon.

Because we had very few expenses during the pandemic, the RRTA has built up their cash reserve so we can easily pay the room rental and subsidy, however, moving forward, we don't know how much we will be able to subsidize future luncheons. This means costs for future luncheons may increase.

Meanwhile please come and enjoy the Fall Luncheon and AGM. We are looking forward to seeing you all again.

Richmond Retired Teachers' Association Treasurer's Report (Summer 2022)

There is a lot of background detail in the 2022-23 budget, so this report will try to be much briefer. We ended the fiscal year with about \$12,050 in cash. This is about \$5,000 greater than pre-pandemic. We haven't been able to spend on our membership in the form of luncheons or programs and speakers, but membership income continued. The 2022-2023 budget reflects an estimated correction to lower our cash balance, by providing a greater than usual subsidy for the 2022-2023 luncheons and by offering complimentary luncheons to lifetime members, 'plus one'.

At the time of writing, attendance is unknown although we do know that meal costs have risen considerably. The budget is a worst-case scenario estimate with a safe bottom line. We can always change course by Christmas.

The other part of this report is to reach out for a replacement Treasurer. I can partner, train, mentor or just get out of your way. It is a way to give back to society as a whole, in any case.

	Newsletter and Operating expenses are incre	ased because act	ual is close to the existing	budget. The	other					
	significant expense, an extra subsidy to luncheons , has been estimated for two subsidies in the coming									
	fiscal year (See the notes below). If we are able to hold a Christmas luncheon, we have room to decide if a second subsidy is reasonable. The Christmas luncheon has more costs: menu price, choir and pointsettias.									
	We are not permitted to spend on donations. The Canada Revenue Agency requires that we spend only for the benefit of the membership. Luncheon subsidies meet this stipulation. Based on the 2019 cost of just under \$30 to Mayfair Lakes in September, a greater subsidy to members is offered for consideration. 67 members attended the Back to School luncheon in 2019. The willingness and ability of members to attend such a gathering is unknown. While fairness to members who are unwilling or unable to attend is always									
	a difficult consideration, another option has r	a difficult consideration, another option has not appeared, except to increase Zoom utilization for Programs,								
	and those are already available through many	platforms. Howe	everever, Programs and Sp	eakers

	The new 2022-2023 Budget shows a loss, v	vhich would only	occur if every budget alloo	cation was

Therefore, a great deal of	number-crunching came about because the Finance	e Committee con	sidered the possibility of s	ubsidizing or	ne					
	luncheon more generously, then offering one	luncheon paid to	new members, but we re	alized we wo	uld					
	have difficulty pinpointing cut-off dates (before Covid, during Covid) and possibly high numbers came up.									
	So then we considered lifetime members and their spouse, companion or caregiver. There are about 20									
	lifetime members and I have over-estimated	15 lifetime memb	ers plus companion, for co	omplimentar	y					
	luncheons. As well, I have included a larger th	an the usual \$5 si	ubsidy for regular guests.							
	Mayfair has given a starting cost of \$30 for September's luncheon. Sep 2019 was \$22. I have budgeted September at \$50, and \$70 for December, allowing for GST, gratuity and a new room charge of \$450. Final figures are complicated to estimate due to the unknowns of attendance, both member paid and complimentary. The social committee continues to explore other venues but Mayfair is still the best value when accessibility, parking and buffet format are considered. This is an unusual budget and we don't want to be as generous									
	for just luncheon-goers in future. The CRA-dri	ven goal is to red	uce cash reserves.							
	The bottom line for 2023 could be a loss of \$8,900. Cash <u>could</u> drop to \$3,600 by June 2023, only if we spent all of the budget in all of the accounts, and it's unlikely, yet still provides a safety net. Although the Board of									
	Directors has voted to accept this budget, please remember it is just a budget, not actual expenditures, and									
	that we are able to and will, monitor and adju	ist, cash flow as e	stimates become reality.


